Preface

How to Use this Book

There are two main sections to this book: the reading and the writing. The *Practice tests* and the **exercises** have been numbered separarely in each section. Answers for the exercises and the Practice tests are in the Answer *Key* at the end of the book.

Section 1 Reading

Section 1 gives you:


- an overview of the test which describes the Academic Reading, the form of the instructions and the question types.
- a Practice Reading test. You should do this test giving yourself exactly one hour.
- the question types in detail. For each question type there is an *Explanation* at the beginning. The purpose of this explanation is to help you understand the purpose of the question type and learn the appropriate skill for answering the question. After the explanation, there is a *Practice and Discussion* section. Here useful skills and strategies will be explained in detail. Then there are exercises for you to practise the skills. Follow the instructions for each activity and, when you have finished, check your answers in the Answer Key. Because working fast and efficiently is very **important** in tests, many exercises have a Time target. The Time target gives you a suggested rime limit for the activity.
- two Practice Reading tests.

Section 2 Writing

Section 2 begins with an overview of the Writing test and the instructions then describes in detail the two Writing tasks.

You can do the sections in any sequence you wish.





About the Reading Test

The IELTS Academic Reading test takes 60 minutes.

There is a question booklet which contains all the instructions, the reading passages and the questions.

There is an answer sheet (on the back of the Listening test answer sheet). You **must** put all your answers on the answer sheet while you are reading. There is no time allowed at the end for transferring answers.

The test is divided into three sections. Each section is more difficult than the one before. Each reading passage is between 700 and 1000 words long.

There are between 38 and 42 questions. The questions may come before or after the readings. There is a variety of possible question types. There may be examples of how to answer the questions. There is a more detailed explanation of the questions later in the book.

You may mark or write on the question paper, but all answers must be written on the answer sheet. Remember you must write your answers on the answer sheet as you go. Unlike in the Listening test, there is no time to transfer them at the end of the test.

Getting the Instructions Right

The written instructions in the reading booklet are always given in *italics*. Important aspects of the instructions are also in **BOLD ITALIC CAPITALS**.

The instructions in the Reading test depend on the type of question. As you work through this book, take particular note of instructions. Getting to know the instructions now means that you will be able to see quickly what you have to do in the actual test and will be less likely to make the more common mistakes.



Following are seven examples of instructions which are typical of those you will find in the IELTS Academic Reading booklet. Read each of the instructions below and the explanations that follow.

EXAMPLE 1

Questions 1-5

Choose the appropriate letters A-D and write them in boxes 1-5 on your answer sheet.

This instruction typically applies to multiple-choice questions. One of the answers - A, B, C or D - will be the correct answer.

EXAMPLE 2

Questions 11-15

Reading Passage 2 has five sections A-E. Choose the most suitable heading for each section from the list of headings below. Write the appropriate numbers (i-ix) in boxes 11—15 on your answer sheet.

Note: There are more headings than sections so you will not use all of them. You may use any heading more than once.

This means the sections are given the headings A, B, C, D and E. The answer choices, (i.e. the headings) usually appear in a box and will be numbered using roman numerals. You will write those roman numerals on your answer sheer.

There are always extra headings. Although you are told 'You may use any heading more than once.' you will rarely need to do so.

There can be a question of this type asking for a heading for only one paragraph or a heading for the whole passage.

Often there will be an example given. It is unlikely this example will be used again.

EXAMPLE 3

Questions 11-15

Choose **ONE** phrase A-F from the list to complete each key point. Write the appropriate letters A-F in boxes 11-15 on your answer sheet.

The information in the completed sentences should be an accurate summary of points made by the writer.

Note: There are more phrases A-F than sentences so you will not use them **all**. You may use any phrase more than once.



This is like the headings instruction. Usually you will have to match the first half of a sentence with the second half. The completed sentences will always be paraphrases or summaries of information in the text.

A similar instruction could ask you to match lists of points such as causes and effects, or advantages and disadvantages.

It is possible that you will use a phrase more than once.

EXAMPLE 4

Look at Questions 12-15, Classify the following as linked in the. passage to:

Write the appropriate letters M, B or F in boxes 12-15 on your answer sheet.

READING PASSAGE 1

RELIGIOUS DENTISTRY

Bali is, without doubt, one of the most culturally rich islands in the world. In fact, its carved temples, dances and immaculately manicured rice terraces do all seem too perfect to be true, even down to the people's smiles. But take a closer look at those smiles and the perfect teeth do seem a bit too perfect, and for good reason. Those flattened teeth are the result of an important piece of dentistry that every young Balinese man or woman experiences in their life, known as potong gig), or tooth filing.

Tooth filing is part of Bali's religious traditions and is not performed for cosmetic reasons. In fact, so important is the tooth filing ceremony that without it, the Balinese believe they may experience serious social or behavioural problems later in life, or their personality may change altogether.

Balinese religious life is surrounded by a belief in a variety of deities - gods and demons that inhabit different levels of the cosmic and real worlds. These deities range from the most holy in the mountains to the lowest that inhabit the ground and the sea. There are gods and goddesses in every walk of life which have special forces of their own. They inhabit temple statues, trees, even fly through the air. They exist together in a dual concept of good and evil, clean and dirty, etc. As such, both the good and the evil spirits must be appeased, and

offerings are thus made at the myriad temples on the island.

It is not only the good spirits that are worshipped, for Bali has a dark and evil side too. Terrifying demons monsters walk the earth and although they are seldom seen, they too must be appeased. These demons can take over and inhabit the body of an animal or human and wreak havoc in the community, so it is very important to strike a balance between offerings made to all spirits that swarm the island. At every stage in a person's life, he or she is susceptible to influences of the supernatural — from demons and layak, to good spirits which may bring luck. Purification of the body and mind is therefore central to Balinese religious life and the tooth-filing ceremony represents one such rite of passage from childhood to becoming an adult.

According to the Balinese, long pointed teeth resemble the fangs of animals and these give the person characteristics of the animal sides of human nature and ferocity. The Balinese believe there are six of these evil qualities: desire, greed, anger, intoxication, irresoluteness and jealousy. These are liable to flare up, along with animal instincts, when the canines are still sharp. To prevent this, the points of the canines are filed down, together with any prominent points of the lower teeth in a special *potong gigi* ceremony. Although this may prevent



the person taking on animal instincts and beautify the smile, it is, unfortunately offset by early tooth decay since the protective enamel is removed from the points of the teeth, exposing them to acid decay. The situation is exacerbated in those who go on to chew betel nuts, since the caustic lime rapidly attacks the teeth.

The *potong gigi* ceremony usually is undertaken for members of the same family together since it is a very expensive occasion to host. It is often necessary to wait until the youngest child is of age. Girls are ready for tooth filing only when they have reached sexual maturity and boys are usually older, about 17 or at least after puberty. A person must have their teeth filed before

marriage and since marriage is early, the ceremony is often undertaken as a prenuptial event.

The high priest is consulted first to choose an auspicious day from the Balinese calendar. Every day has a different function - a best day for rice planting, best day for cremations and other festivals, as well as tooth-filing days. The dentist's chair, so to speak, is specially constructed for the ceremony from bamboo in the form of a rack covered with coconut leaves, blankets and a variety of offerings and frangipani flowers. Surrounding the platform is food for the guests and a huge display of skewered suckling pig, fruit, and whole roasted chickens adorn the entrance to the ceremony room.

DOMESTIC PETS IN NEW URBAN AREAS

The role of urban design in successful pet ownership

This paper summarises the findings of an investigation into the role of urban design in successful pet ownership. There are several reasons why planners should consider pets in decisions about residential and open space development.

A People are not generally aware of the popularity of pet ownership in Australia. The Morgan Research surveys estimate that in 1992, 37% of Australian households owned one or more dogs, and 30% owned one or more cats. Fifty-three per cent of all households owned either a dog or a cat. Petowning households are clearly a substantial group within the community.

B Research shows that pets play an important role in teaching children about sharing, caring, communication and responsibility. They also act as companions and protectors, stress relievers and in some cases help to foster family cohesion. While pets are traditionally associated with familytype households, they are just as important to households without children: indeed they are often surrogates for children in childless families. This applies particularly to the elderly, who usually form very close associations with their pets. In an era when the population is ageing and more people are living alone, pets can provide valuable relief from loneliness.

C Urban pet management has been the subject of extensive debate among veterinarians and those involved in local government for some time. Part of the reason is that people complain more readily about other people's pets than ever before. Emphasis on urban consolidation has meant that smaller homes and back gardens and multi-dwelling developments not only discourage people from owning pets but also place greater demands on scarce public open space. Pet owners may face tougher restrictions from either their local council or resident management committee.

D The term socially responsible pet ownership has emerged to describe a set of responsibilities to which pet owners are now expected to adhere. In meeting their responsibilities pet owners need to consider:

- Providing an enriching environment to reduce unwanted behaviour; e.g. excessive barking.
- Confining dogs to their premises. The advantages of this include protection from catching disease, being run over and fighting. Ideally cats should be confined to the house at night for their own protection where practicable.
- Training pets to alter unacceptable behaviour.
- Exercising dogs, especially if they spend long periods on their own.
- E It might be tempting to prescribe different pets for different types of housing. Some people already have firm views about pets and housing type,



mostly in relation to dogs, e.g. that the only environment for a dog is in conventional detached housing or that a "big" dog is only suitable in the country. However, suitability is as much dependent on the quality of space as it is on the quantity.

A dwelling that overlooks areas of activity is ideal for pets because it increases the amount of stimulation that can be received from the property, e.g. dwellings that overlook a park or are adjacent to a busy street. This is one way to alleviate boredom and the negative behaviours that sometimes result.

Preferably a dog should have access to some outdoor space. Open space is not essential for a cat provided an enriching environment is maintained indoors, e.g. a bay window or internal fernery. Ideally dogs should have access to all areas of open space on a property. On the whole a dog's behaviour is likely to be better if he or she can see the street. Although the dog may bark at passersby in the street, there will be less likelihood of excessive barking that might arise through boredom. Providing a dog with surveillance of the street also enhances public security - a very positive benefit.

F With adequate fencing, a dog will be confined to the property. Cats are

less easily constrained and are discussed below. The standard paling fence will restrain almost all dogs. They are recommended for side and rear boundaries. Solid front fences limit the view of the outside world and are not recommended. The dog will tend to be less roused by sound stimuli if he or she can see passers-by or activities in the street. However, it is important to ensure that the dog cannot get through the fence. Furthermore, all gates should be fitted with a return spring self-closing device.

Cats are not as easily restrained as dogs as they are more agile and have quite different notions of territoriality. Mostly this does not create a problem, although difficulties may arise in environmentally sensitive areas where cats may prey on wildlife. It is recommended that cats be confined to the house at night for their own protection.

The pleasures and benefits of pet ownership should be available to everyone. However, owning a pet brings with it responsibilities to which we are increasingly being called to adhere. It is hoped that the guidelines will encourage people to think about pets in decisions about residential and community development. If they do, pet ownership will not be prejudiced by the push for urban consolidation. Questions 19-24

Australian Mining Companies In The Asia-Pacific Region

Environmental impact on people

Mining operations by their very nature have major impacts, positive and negative, on the local area and on local communities. They are usually in remote places and the people affected are often isolated or neglected communities.

It is inevitable that mining operations will disturb the environment in a fairly dramatic way. Forest cover may have to be cut down to clear the site of the mine or for access roads. Tunnels or open-cut pits are dug. Overburden* is removed and dumped nearby, usually to erode slowly into nearby streams and rivers. Tailings** from the ore processing plant have to be put somewhere — preferably into an on-site tailings dam, but more likely straight into a river and/or the sea.

Mine tailings may contain some dangerous chemicals, but the major problem is usually the huge amounts of solid sediment that they put into the river system, and the effect this has on water quality and marine life. This can directly affect the livelihood of people living downstream who depend on the river for fish, for drinking water for themselves and their animals, or for cooking or washing. Heavy sedimentation can silt up rivers, making transportation difficult and causing fields and forests by the river banks to flood.

Other environmental effects can include air pollution from trucks tearing along dusty access roads, or more seriously, fumes from ore processing plants. Kelera, a woman who lives with her husband and two school-age children near the Australian-owned Emperor Gold Mine in Fiji, describes it thus:

When the gas comes, sometimes in the morning, if falls like a mist, and all the children start coughing, and we cough too. The people who get asthma, they are the ones who are really frightened to death. But what can you do? When the gas comes you have to breathe it... You know how strong it is? I tell you. The chili and the betel leaves that we grow, they just die. It's as though you took hot water and spilled it on the grass, and the next day you go and see what it looks like. It's just like that.

Social impact

The social impact of a modern mining operation in a remote area can also be great. Some people may have to move

off their land to make way for the mine. Many more will probably relocate themselves voluntarily, moving in from more remote areas to the mining road or the mining settlement, drawn by the prospects of jobs and money, trade stores and health clinics, or just by the general excitement of the place. In many cases the men will come in by themselves, leaving the women to fend for themselves back in the village. Traditional agriculture and other pursuits are, as a result, often neglected.

But the social environment into which they come is a culturally alien one which can undermine traditional kin and gender relations and traditional authority and control, often with bitter consequences.

Large amounts of cash will normally be injected into the local community in the form of royalties or compensation to landowners, wages to mine workers or payments to sub-contractors. While this can be very beneficial it can also lead to inequalities, disputes and problems.

Those in the local community who acquire cash from wages or compensation and the power that goes with it are not necessarily those who by tradition hold power in that society. The very advent of the cash can have a disruptive effect on traditional social structures.

Also in societies where resources including cash are owned communally and shared out according to traditional rules and precedents, the injection of very large amounts of money can strain the rules and tempt some to keep more than their entitlement, thus causing internal rifts, disputes and fighting.

Disputes between landowners and mining companies over payments or compensation are also common, and can lead to violent reactions against landowners by the police or armed forces, or repression by the authorities.

For and against

Mining also, of course, brings considerable benefits. Locally it provides jobs and incomes, and for those who use their income wisely, an escape from grinding poverty and a life of hardship and struggle. It also brings development and services such as roads, wharfs, airstrips, stores, health clinics and schools, to areas which are usually remote and often neglected by government. The advent of health care and educational facilities to remote areas that would otherwise not have them can be especially beneficial.

Opinions about a mine will usually vary. Those most in favour tend to be those living near the mine and enjoying its facilities, who have been generously compensated for loss of land or damaged environment, or who are earning good money as mine workers or sub-contractors. Among those least in favour will be women living in or near the mining settlements who have to put up with alcoholism, domestic violence, sexual harassment or other social ills, and people living downstream, far enough away from the mine to be receiving little or no compensation but who nevertheless suffer its polluting effects.

The Question Types

There are four main question types in the Academic Reading Module. These are:

- overview questions
- specific information questions
- viewpoint questions
- summarising questions.

Overview questions

These questions will often require you to choose a heading for different sections of the reading. You will be given a number of possible headings to choose from. There are always more headings than you will need. You will not always have to give a heading to every section. Sometimes these questions will be multiple-choice questions asking you what the topic of a particular section is.

Specific information questions

These questions could take several forms. The most common are:

- multiple-choice
- questions requiring a short answer
- completing sentences
- · matching lists of items
- classifying items.

Viewpoint questions

The most common form for this question requires you to identify whether statements agree with the views or claims of the writer or of other people mentioned in the reading.

There could also be multiple-choice questions about the writer's attitude.

Summarising questions

The most common form for this type of question requires you to complete a short summary of information contained in the reading. You could also be asked to match two phrases or two parts of a sentence to summarise some of the information contained in the passage. You may also have to choose a title for the whole passage, usually one of four answer choices.

Each of these question types will be illustrated and practised in detail in the relevant sections which follow. Any question type can occur with any reading.

Overview Questions

For each section of the Reading test, the best strategy is to read all instructions, questions and examples very quickly. This gives you a clear focus when you read the passage and helps you to decide the best strategy for dealing with the questions.



If there are overview questions which require you to match headings with sections of the text, they always come before the reading. If there are questions which require you to choose the best topic from several options, they come after the reading. In both cases the best strategy is to quickly skim the passage.

- Read the first sentence of each paragraph.
- Skim the rest of each paragraph looking for key words.
- Match the headings with the sections.
- Write the heading numbers beside the appropriate sections in the test booklet.
- Read the text more closely to confirm your choices.

DISCUSSION

You already know that heading viii has been used in the example. Therefore, it will probably not be used again.

You do not have to choose a heading for section B, even though it has been given a section letter. The IELTS does not always require you to choose a heading for every section. Check this before answering the questions.

Section C (Question 1)

In the first sentence in Section C, there are two key words that match two of the answer choices. These are *community* and *leadership*. Also, the word *involvement* is a synonym of *participation*. Therefore, at this stage, you would write in your question booklet iii and v. If you look at the first sentence of the second paragraph in this section, you find several other key words which indicate that your choices are on the right track. Can you find any clues that might help you decide which of these two is the correct choice?

Section D (Question 2)

This time there are no words the same as the words in the answer choices. However, there are close synonyms which indicate that choice vii might be the answer here. These are the words business and employers.

Section E (Question 3)

The first sentence and answer choice ii both mention the World Bank. But when you read the first sentence of the second paragraph you see that services, such as water, sanitation, street foundations and power are mentioned. These are all types of infrastructure. So you must also consider answer choice vi for this section.

Section F (Question 4)

This sentence talks about *cityward migrations*. People coming to the city are newcomers. But *housing* is also mentioned in this sentence as well as in answer choice iv. Answer choice i mentions accommodating newcomers, which includes housing.

So in an IELTS test you would write in your question book: iii and v beside Section C, vii beside Section D, ii and vi beside Section E, and i and iv beside Section F. Now you will have to read the passage in greater detail to confirm your choices and make your final selections.

However, in the real IELTS you cannot spend your time reading the complete passage in order to confirm a few answers. You need to keep other questions on that passage in mind at the same time. As you are reading, you should mark sections of the reading passage that might provide answers to these questions.

Look at some other questions for this same passage before you begin reading.

Encouraging a dialogue between city officials and shantytown dwellers can produce more effective initiative than top-down planning. Redirected, local skills and organisation can carry out low-cost schemes on a large scale, as in El Salvador. Establishing local administrative centres helps to focus community spirit, and allows a degree of self-management.

D Current thinking aims at providing incentives to employers, through aid and technical advice, and the provision of small workshops. The World Bank now funds many such schemes. The huge informal economy of many large cities (between 40% and 60% in Jakarta, Bombay and Lima, for example) is a major provider of jobs, and at present receives negligible support through government credit.

E The World Bank has funded improvement schemes worldwide. They include shantytown and transport improvements. The Francistown Project in Botswana succeeded in giving 95% of households clean water, roads, and street lighting. Squatters were given legal tenure.

F Whenever cityward migrations have reached unusual proportions, conventional housing and infrastructure services have been hard-pressed to cope. The many millions

of poor people now crowding into slums and squatter settlements cannot afford even the simplest permanent housing schemes (86% of urban populations in Bangladesh, for instance, are below the absolute poverty line).

Authorities are being forced to take a different line, tackling only the most basic provision themselves, and letting the settlers do the rest, with minimal aid. DISCUSSION

Question 1 (Section C)

Closer reading of this section shows the two paragraphs focus more on community involvement and cooperation than on leadership, therefore heading iii is better than v.

Question 2 (Section D)

This section talks about the informal sector as a source of jobs, so the best heading is still vii.

Question 3 (Section E)

Closer reading of this section shows the World Bank is only mentioned as a provider of funds. There is much more information about the provision of infrastructure in cities, so your choice would be vi.

Question 4 (Section F)

There is discussion of several aspects of housing and services for migrants to the city, so i is a better choice than iv, which is only about housing.

Questions 5-9

As you were reading, did you underline the following: Le Corbusier, Niemeyer, El Salvador, informal economy, World Bank, and between 40% and 60%? If you did, it would be fairly easy for you to find the answers to Questions 5–8. Question 9 asks for the author's suggestion or recommendation. This is often found towards the end of a passage. In this case it is in the last sentence.



Question 5 (Section A)

Le Corbusier and Niemeyer appear to be the names of people, as all the answer choices are occupations. Choices A and C are not broad enough for the designers of cities, which seems to be what this section of the passage is about. Therefore the answer is **B**. Of course, it is possible that you know they are architects.

Question 6 (Section C)

The example of El Salvador immediately follows the sentence 'Community involvement and leadership are critical.' It is followed by information between commas which is less important, so the main sentence here reads 'El Salvador...boasted an almost model scheme.' Because of the context the scheme must be one involving a community self-help scheme as described in the paragraph. The answer is C.

Question 7 (Section D)

For this question you should look for numbers and possibly also a % sign. You can find numbers and % signs in several sections of the reading. When you quickly read the sentences containing numbers and % signs, you find that Section D mentions the 'informal economy'. The answer is B.

Question 8 (Section E)

The World Bank is mentioned in two sections of the Reading: D and E. But only in section E is it followed by an example of a particular scheme receiving funding: Francistown. The answer is C.

Question 9 (Section F)

The last sentence of the reading passage reads 'The most urgent need, however, is for greater rural investment to slow the flood to the cities.' This matches answer choice A which is 'invest more in rural areas'.

A Under Pinochet, Chilean fruit exports boomed. The country has remained a major supplier of temperate fruits - grapes, nectarines, plums, peaches, pears and apples to North America and Europe. More than 95 per cent of grape imports to the US are from Chile. Highly perishable exports prompted Cardoen Industries, better known for its weapons and explosives, to produce refrigerated containers for sea and air shipments. Almost all Chile's orchards are less than one hundred miles from a seaport. Over half of Chile's fruit exports are controlled by five transnational companies.

B Most of the estimated half a million jobs created by the fruit industry are temporary and seasonal. Over two-thirds of the labour force in Chile is now employed on a temporary basis, 60 per cent of whom work in the fruit sector.

C In the late 1980s in a major fruit-growing valley, temporary workers, employed for about three months of the year, were paid between \$2 and \$4 per day; one hectare (2.5 acres) of grapes in the valley earned the owner just under \$5000.

READING PASSAGE

(i) More and more women are now joining the paid labour force worldwide. They represent the majority of the workforce in all the sectors which are expanding as a result of globalisation and trade liberalisation – the informal sector, including subcontracting; export processing or free trade zones; homeworking; and the "flexible", part-time, temporary, low-paid labour force. Even in countries which have low levels of women paid workers, such as the Arab countries, employment is rising.

In South-East Asia, women represent up to 80 per cent of the workforce in the export processing zones, working mainly in the labour-intensive textile, toy, shoe and electronic sectors. In Latin America and the Caribbean, 70 per cent of economically



- active women are employed in services. Many women in South-East Asia are moving from manufacturing into services.
- (ii) Long excluded from many paid jobs and thus economically dependent on husbands or fathers, paid employment has undoubtedly brought economic and social gains to many women. For many previously inexperienced young women, the opportunity to gain financial independence, albeit limited and possibly temporary, has helped break down some of the taboos of their societies and prescriptions on women's behaviour.

Any gains, however, should be seen in a wider context. Declining economic and social conditions throughout the world, in particular declining household incomes, have compelled many women to take any kind of paid work to meet their basic needs and those of their families. The jobs available to them are, in the main, insecure and low-paid with irregular hours, high levels of intensity, little protection from health and safety hazards and few opportunities for promotion.

- (iii) Women's high participation in informal employment is partly due to the fact that many jobs in the formal economy are not open to them: they are actively excluded from certain kinds of work or lack access to education and training or have domestic commitments. The increase of women's participation in the informal sector has been most marked in the countries of Sub-Saharan Africa where sharp economic decline and structural adjustment policies have reduced the official job market drastically.
- (iv) Job gains for some women have meant losses for others. Female employment in export production is increasing in Bangladesh, Vietnam and El Salvador, for instance, while women in South Korea, Taiwan and Hong Kong are faced with redundancies as the industries which have relied on their labour for three decades (textile, clothing, shoe and electronics) relocate elsewhere. (In South Korea, industries which tend to employ men steel, petrochemicals, electricity, automobiles, shipbuilding, machinery have received government subsidies to stay put.)

As domestic markets are opened up to international competition and quotas which restricted the quantity of imports from any one country are abandoned, cheap, subsidised foreign imports are threatening the livelihoods of many women, small producers



- and entrepreneurs in "cottage industries". In countries such as India and Bangladesh, for instance, more than 90 per cent of economically-active women work in the informal sector at jobs such as hand loom weaving.
- (v) Far from escaping patriarchal control, the industrial setting invariably replicates it, the head of the factory taking the place of husband or father. To attract investors, some Asian countries such as Malaysia and Thailand emphasise the "dexterity of the small hands of the Oriental women and traditional attitude of submission". Women workers are particularly exposed to sexual harassment, a form of violence which reflects the subordination they have to submit to to be allowed to work. Complaints often lead to dismissal.
- (vi) In general, women are paid less than men are, and women's jobs pay less than men's jobs. On average, most women earn 50 to 80 per cent of men's pay, but there are considerable variations. In Tanzania, which ranks first in the world for pay equality, women earn 92 per cent of what men earn; in Bangladesh, they earn 42 per cent. Women also have less job security and fewer opportunities for promotion. Higher status jobs, even in industries which employ mostly women, tend to be filled by men.
- (vii) In addition, women usually have to continue their unpaid domestic and caring work, such as of children, the sick and the elderly, which is often regarded as women's "natural" and exclusive responsibility. Even when they have full-time jobs outside the home, women take care of most household tasks, particularly the preparation of meals, cleaning and childcare. When women become mothers, they often have no option other than to work part-time or accept home work.

DOMESTIC PETS IN NEW URBAN AREAS

The role of urban design in successful pet ownership

This paper summarises the findings of an investigation into the role of urban design in successful pet ownership. There are several reasons why planners should consider pets in decisions about residential and open space development.

A People are not generally aware of the popularity of pet ownership in Australia. The Morgan Research surveys estimate that in 1992, 37% of Australian households owned one or more dogs, and 30% owned one or more cats. Fifty-three per cent of all households owned either a dog or a cat. Pet-owning households are clearly a substantial group within the community.

B Research shows that pets play an important role in teaching children about sharing, caring, communication and responsibility. They also act as companions and protectors, stress relievers and in some cases help to foster family cohesion. While pets are traditionally associated with family-type households, they are just as important to households without children - indeed they are often surrogates for children in childless families. This applies particularly to the elderly, who usually form very close associations with their pets. In an era when the population is ageing and more people are living alone, pets can provide valuable relief from loneliness.

C Urban pet management has been the subject of extensive debate among veterinarians and those involved in local government for some time. Part of the reason is that people complain more readily about other people's pets than ever before. Emphasis on urban consolidation has meant that smaller homes and back gardens and multi-dwelling developments not only discourage people from owning pets but also place greater demands on scarce public open space. Pet owners may face tougher restrictions from either their local council or resident management committee.

D The term socially responsible pet ownership has emerged to describe a set of responsibilities to which pet owners are now expected to adhere. In meeting their responsibilities pet owners need to consider:

- Providing an enriching environment to reduce unwanted behaviour; e.g. excessive barking.
- Confining dogs to their premises. The advantages of this include protection from catching disease, being run over and fighting. Ideally cats should be confined to the house at night for their own protection where practicable.
- Training pets to alter unacceptable behaviour.
- Exercising dogs, especially if they spend long periods on their own.



E It might be tempting to prescribe different pets for different types of housing. Some people already have firm views about pets and housing type, mostly in relation to dogs, e.g. that the only environment for a dog is in conventional detached housing or that a "big" dog is only suitable in the country. However, suitability is as much dependent on the quality of space as it is on the quantity.

A dwelling that overlooks areas of activity is ideal for pets because it increases the amount of stimulation that can be received from the property, e.g. dwellings that overlook a park or are adjacent to a busy street. This is one way to alleviate boredom and the negative behaviours that sometimes result.

Preferably a dog should have access to some outdoor space. Open space is not essential for a cat provided an enriching environment is maintained indoors, e.g. a bay window or internal fernery. Ideally dogs should have access to all areas of open space on a property. On the whole a dog's behaviour is likely to be better if he or she can see the street. Although the dog may bark at passers-by in the street, there will be less likelihood of excessive barking that might arise through boredom. Providing a dog with surveillance of the street also enhances public security — a very positive benefit.

F With adequate fencing, a dog will be confined to the property. Cats are less easily constrained and are discussed below. The standard paling fence will restrain almost all dogs. They are recommended for side and rear boundaries. Solid front fences limit the view of the outside world and are not recommended. The dog will tend to be less roused by sound stimuli if he or she can see passers-by or activities in the street. However, it is important to ensure that the dog cannot get through the fence. Furthermore, all gates should be fitted with a return spring self-closing device.

Cats are not as easily restrained as dogs as they are more agile and have quite different notions of territoriality. Mostly this does not create a problem, although difficulties may arise in environmentally sensitive areas where cats may prey on wildlife. It is recommended that cats be confined to the house at night for their own protection.

The pleasures and benefits of pet ownership should be available to everyone. However, owning a pet brings with it responsibilities to which we are increasingly being called to adhere. It is hoped that the guidelines will encourage people to think about pets in decisions about residential and community development. If they do, pet ownership will not be prejudiced by the push for urban consolidation.

DISCUSSION

Your initial reading of the first sentence of each paragraph should have enabled you to make the following choices.

Heading (ix) is the heading for Section E in the example. Therefore, you will probably not use it again.

Section A (Question 14)

The two key words in the headings and the first sentence are 'popularity' and 'ownership'. Therefore, you should note both (i) and (iv) beside this section.

Section B (Question 15)

The key words and phrases here are 'research' and 'benefits' in the headings with 'play an important role' in the first sentence. So you should note (iii) and (x) beside this section.

Section C (Question 16)

The key words here are 'criticisms' and 'cities' in the headings. In the first sentence of the passage, there are no exact matches for these, but there are synonyms. The most obvious is 'urban' for cities. 'The subject of extensive debate' is another clue here. If there is public debate over a matter, this generally indicates that some people are criticising the situation. Note (vi) beside Section C.

Section D (Question 17)

The phrases 'Pet owners' and 'pet ownership' are almost the same and 'obligations' are similar to responsibility, so 'socially responsible' is relevant here. Put (viii) beside Section D.

Section F (Question 18)

The first sentence of paragraph 1 talks about confinement of dogs. So (ii) might be appropriate, but the first sentence of paragraph 2 talks about restraining cats. The heading 'Keeping pets under control' is broader than either of these and covers both. So choose (vii) for this.

You should not have chosen (v) for any of them at this point, though it might apply to either Section E or F. Therefore, you should have kept it in mind when you read the passage more carefully.

Question 19

The information you need to answer this question is in the first paragraph which gives figures on pet ownership in Australia. The relevant sentence says 'Fifty-three per cent of all households owned either a dog or a cat.' The statement for question 19 says '...more than half of Australian families have both a cat and a dog.' The answer is N or NO.



Question 20

The reading talks about dogs needing exercise if they are alone a lot and also talks about dogs being bored. However, there is no mention of pets being lonely when they are left alone. While you may believe that pets get lonely when they are left alone, there is nothing in this passage about pets being lonely. The answer is NG or NOT GIVEN.

Question 21

Section E is where you should look for the answer to this question. This section talks about pets having a quality environment with plenty of stimulation. The third paragraph in this section says that it is **preferable** for a dog to have outdoor space. It also says 'open space is not essential for a cat'. Therefore you can conclude that outdoor space is good for pets but it is **not absolutely essential** so the answer is Y or YES.

Question 22

The answer to this question can be found in Section F. The first sentence of this section points out that fences are effective for keeping dogs off the street. The fifth sentence here says 'Solid front fences limit the view of the outside world and are not recommended.' The answer is Y or YES.

Question 23

The answer to this is in the last paragraph of Section E, which says 'Although the dog may bark at passers-by in the street, there will be less likelihood of excessive barking.' The use of 'excessive' (which means too much) tells you that barking is not desirable. Therefore you can see that dogs should **not** be encouraged to bark. The answer is N or NO.

Question 24

This sentence is a paraphrase of the last sentence of the second paragraph in Section F. The answer is Y or YES.

Question 25

This question requires you to decide which answer choice best summarises the views of the writer. The sections on Viewpoint Questions and Summarising Questions will give you more practice with questions like this. In this case you should choose D as this most closely reflects the main points of the reading.

- A is not suitable because it contradicts what the writer says.
- B could be said to partially reflect the views of the writer, but only on one or two points.
- C does reflect the views of the writer, but the focus is wrong. This choice focuses on people rather than on pets.
 - D reflects the views of the writer, and summarises the main points with the focus on pets.





EXERCISE 4

Time target - 10 minutes

In this exercise you can practise two types of specific information questions: short answer questions and multiple-choice questions. In the IELTS test, these questions usually follow the reading. Nevertheless, you should turn to the questions first and:

In this reading passage you should use the headings and the typographic conventions to help you quickly scan to find the answers. For example, if the question asks about WHO, then you scan the passage to find those capitalised letters.

READING PASSAGE

UNICEF, MALNUTRITION AND MICRONUTRIENTS

UNICEF has continued to be at the forefront of advocacy and support for the implementation of programs to combat child malnutrition. A condition for designing effective programs to fight malnutrition is understanding the causes of the problem and recognising how complex they are.

Micronutrients

IODINE: Some of the most rapid and important progress in UNICEF programs is in the area of salt iodisation. The strategy of universal salt iodisation (USI) has been widely accepted in all regions, and the goal of USI by end-1995 has been met in virtually all of Latin America and in many countries in other regions. During the year, a number of countries with a high prevalence of iodine deficiency in which salt iodisation was previously thought to be virtually impossible, such as Pakistan and Indonesia, started to iodise at least half of all salt reaching consumers. To achieve this, UNICEF offices supported a range of innovative and flexible approaches, for example the establishment of an "Iodised Salt Support Facility" in Pakistan, to provide training, supplies and quality control to the 800 or so small salt crushers in the country.



Enormous progress was seen not only in getting iodine into salt but also in the promulgation of laws to give teeth to monitoring and quality control efforts. UNICEF, WHO and the International Council for the Control of Iodine Deficiency Disorders (ICCIDD) sponsored a forum in 1995 to consider the iodisation and monitoring challenges faced by countries in which salt is brought to market by many small producers rather than larger enterprises.

A technical monograph on practical ways of monitoring salt iodisation programs was developed jointly with WHO, ICCIDD and PAMM and widely distributed. Many UNICEF country programs are monitoring household availability of iodised salt, utilising a simple test kit, as part of the Multi-Indicator Cluster Surveys being undertaken to assess progress in meeting the goals of the World Summit.

VITAMIN A: WHO-UNICEF estimates now indicate that over 250 million children still suffer from vitamin A deficiency (VAD) with many millions more at risk. The known effects of VAD on the immune system and thus on child mortality make this a high-priority challenge for UNICEF. In 1995, UNICEF supported surveys of vitamin A status that resulted in widespread deficiency being recognised for the first time in Egypt, South Africa, Kenya and Botswana.

With support from the Micronutrient Initiative in Canada, UNICEF launched projects in 14 countries that will enable innovation in systems of distribution of vitamin A supplements and improvements in monitoring the mortality and morbidity impact of supplementation. A number of countries are building on the successful experience of Guatemala in fortification of sugar with vitamin A. Bolivia and Brazil both launched sugar fortification with vitamin A on a pilot basis in 1995. In Namibia and South Africa, the feasibility of fortifying maize meal with vitamin A is being considered.

UNICEF supports dietary diversification and the consumption of appropriate fruits and vegetables as one of the most potentially sustainable ways for communities to overcome micronutrient malnutrition. Research completed in 1995 with UNICEF assistance pointed to the need to pay further attention to the types of vegetables grown and the type of cooking in order to maximise the impact of home gardening on the vitamin A status of children. In Bangladesh, UNICEF is collaborating with Helen Keller International to assess the impact of a large home gardening project on the vitamin A status of mothers and young children. This information should help to ensure that future programs of this type are designed in the most cost effective way.



IRON: The statement on strategies for reducing iron deficiency anaemia, developed and adopted by WHO and UNICEF in 1995, calls for general supplementation with iron in any population of pregnant women or young children where the prevalence of anaemia exceeds 30%. The results of research trials investigating the impact on anaemia of weekly iron supplements have started to become available. Weekly iron or iron and vitamin A supplements now appear to be a feasible intervention to combat iron deficiency anaemia on a population basis in some vulnerable groups.

UNICEF supported a meeting, jointly with the Thrasher Research Fund and Cornell University, to explore ways of increasing the micronutrient content of foods commonly consumed in countries where micronutrient malnutrition is common. Plant breeders, soil scientists and human nutritionists met to consider the problem and agreed that the micronutrient content of foods had been neglected in the breeding of high yielding (green revolution) varieties of cereals such as rice. With the realisation of the tremendous importance of the micronutrient content of staple food crops to human development, plant breeders agreed that future breeding work should take micronutrient goals into account. The participants also called for research in other priority areas to exploit the potential food-based systems, including the development of programs and policies that influence the choices of consumers and producers to increase the supply and consumption of micronutrient-rich foods.

READING PASSAGE

TRAINING

Training continues to be a major element of labour market reform in Australia. To provide the information necessary for the analysis of training issues and the development and evaluation of training policies and programs, the Australian Bureau of Statistics (ABS) has conducted a number of training surveys.

Training expenditure

Estimates of the expenditure by employers on the formal training of their employees, and of the paid time employees spent receiving formal training were collected in the 1993 Employer Training Expenditure survey, which covered the September quarter 1993. The survey defined formal training as all training activities which have a structured plan and format designed to develop job related skills and competence, and found that total expenditure on formal training during 1 July to 30 September 1993 by Australian employers was estimated at \$1 100 million.

Who received training?

The 1993 Survey of Training and Education found that in the twelve months prior to the survey being undertaken, an estimated 86% of those who had a wage or salary job in the previous twelve months



undertook some form of training. The greatest proportion of wage or salary earners by occupation who undertook training in 1993 were professionals. An estimated 96% of professionals received some form of training in the twelve month period and 70% undertook study or training courses. Among blue-collar workers, clerks at 89% received more training than salespersons and personal service workers, though the latter attended slightly more study courses. Plant and machine operators, and drivers had the lowest proportion receiving some form of training (72%), with labourers receiving slightly more

Length of training course

Of the 5 581 900 wage and salary earners who attended an in-house training course in the twelve months prior to the survey, some 35% of the courses lasted 40 hours or more. Male participants had more attendances at these longer courses than did female participants (42% compared with 27%).

Reasons for training employees

The 1994 Training Practices Survey found that 32% of Australian employers reported providing some formal training for their employees during the twelve month period ending February 1994. Improved work performance was reported by 80% of employers as a reason for training employees. The next two most common reasons for training were to enable employees to move to other positions within the organisation, and to multi-skill employees, (reported by 41% and 40% of employers respectively). Almost half the employers who reported training (44%) also reported that their training expenditure increased during the previous twelve months. Technological change was the factor most often reported as having increased training expenditure (30% of employers), followed by quality assurance (26% of employers). Time constraints and cost constraints were reported as the most common limitations to the amount of training provided by employers for their employees (56% and 41% of employers respectively).

Almost all employers who formally trained employees used external training providers to meet part, or all of their training needs (92%). A lesser proportion (62%) reported providing in-house training for their employees during the reference period. In February 1994, it is estimated that employers in Australia employed 15 800 full-time trainers to provide training for their employees. There was approximately one full-time trainer for every three hundred and fifty employees.



DISCUSSION

Questions 1-3

In this exercise you have to complete the descriptors on the vertical axis of a graph; in this case occupations in a hierarchy based on job levels. For Question 1 the most likely occupation to fit between 'managers and administrators' and 'para-professionals' would be 'professionals'. Questions 2 and 3 are rather more difficult, but the two major groups clearly absent from the axis are general office workers or clerical staff and manual workers. These might be possible answers for 2 and 3 respectively. Remember, you must choose words from the passage for your answers.

Ouestions 4-9

The grammar helps. Each of these answers requires a noun. Words modifying nouns are other nouns and adjectives, so you might also need another noun or an adjective. You will need to be careful about the type of noun. There are no articles (the, a, an) given and the IELTS does not normally require an article as part of the answer, so this would suggest that the nouns you need will be either plural or abstract nouns. A quick reading of the subheadings in the passage and the questions tells you that the reading is about job training, so for Question 4 one possibility is the word 'training'. However, something more specific is probably needed, so look for an appropriate adjective or another noun to say what kind of training.

The sentence in Question 5 could also be completed with the word 'training', but it is unlikely that two questions in a row will require exactly the same answer.

Question 6: What are employers mainly interested in? Profits. The more employees produce, the better the profits, so probably the employers want to improve the productive capability or the productivity of their employees.

Questions 7 and 8: What could make training cost more? There are quite a few possibilities, so this is quite difficult to predict, but you could watch out for such possibilities as the costs of trainers, facilities, technology, etc. What others can you think of?

Question 9: Who or what can provide training? The answer can be people or institutions, so be alert for these. People could be trainers, instructors, or specialists while institutions could be colleges, universities, companies, etc. What others can you think of?

Were questions 4–9 difficult? There is more practice in using the skills you need for answering questions like these in the section on summary questions (p. 66).

READING PASSAGE

SPORT AND RECREATION

A large proportion of Australians, regardless of social position, income and age, participate in some form of sporting activity. The impact of sport extends over a wide range of associated activities in community and commercial fields. Sport is a large industry in Australia encompassing not only participants but also employment within the sporting infrastructure; manufacture of apparel, equipment and other goods (e.g. trophies); tourism and support industries (e.g. printing, media). The sporting activities of Australians include a range of organised and social sport, recreational and leisure activities undertaken both at home and away from home.

Involvement in sport

In March 1993, an ABS survey of persons 15 years of age and over was conducted throughout Australia to obtain information about involvement in sport during the previous 12 months. Involvement in sport was defined to include both paid and unpaid participation in playing and non-playing capacities. Spectator involvement in sport was excluded.

The survey found that one third of the Australian population aged 15 years and over were involved in sport, as players (3.1 million), non-players (0.5 million) or both players and non-players (0.9 million). More men than women were involved as players and as non-players.

Overall, 35% of males played sport compared to 23% of females, and at all ages a greater proportion of males than females played sport. Younger men and women were more likely to play sport than older men and women. Fifty-six per cent of men aged 15 to 24 played sport compared to 39% of women in the same age group. In the 25 to 34 age group 43% of men played sport, compared to 28% of women. Twenty per cent of men and 12% of women aged 65 and over played sport. In Table 11.29 'all players' includes those players who have some non-playing involvement.

For those involved in sport solely as non-players, the 35 to 44 years age group had the highest participation rate (8% for males, 9% for females). Their most common activities were as administrators or committee members.

Sport and recreation participation

Participation in organised and social sporting activities is measured by a quarterly household survey, the Population Survey Monitor conducted by ABS. This survey showed that in 1993–94 the most popular sport was golf, with 384 600 people participating in organised golf (3% of the population), and a further 128 000 participating in social golf (1% of the population).

The most popular organised sporting activities for men aged 15 and over were golf, outdoor cricket, basketball and Australian rules football. For women aged 15 and over, netball, tennis, aerobics and golf were the most popular organised sporting activities. The most popular sports among those aged 55 and over were golf and lawn bowls.

In addition to organised sports, many people are involved in social sport and other recreational activities. In 1993–94 the most popular social sports were tennis and golf, followed by squash and lawn bowls. In February and May 1995 two of the most popular recreational activities were cycling (614 000 in February, 586 000 in May), and fishing (598 000 in February and 636 000 in May). (See Table 11.31.)



People who do not play sport

When people did not play sport, respondents in the survey were asked why not. The most common reason for not participating in sport, given by 39% of men and 43% of women was injury or illness. Men were more likely than women not to participate in sport because of a sports injury (19% compared to 13%) while women are more likely than men not to participate because of an illness. Twenty-seven per cent of men and 20% of women said they had no time or were too busy to participate in sport. Men were more likely than women to be deterred by bad weather while women were more likely to be prevented from participating in sport because they had no child-care facilities. (See Table 11.32.)

Time target – 15 minutes for Part I, Questions 1–11

READING PASSAGE - PART I

THEORIES OF JOB SATISFACTION

What makes some people more satisfied with their jobs than others? What underlying processes account for people's feelings of job satisfaction? Insight into these important questions is provided by various theories of job satisfaction. We will describe two of the most influential approaches — Herzberg's two-factor theory and Locke's value theory.



Herzberg's Two-factor Theory

Think about something that may have happened on your job that made you feel especially satisfied or dissatisfied. What were these events? Over thirty years ago Frederick Herzberg posed this question to more than 200 accountants and engineers, and carefully analysed their responses. What he found was somewhat surprising: different factors accounted for job satisfaction and dissatisfaction.

Although you might expect that certain factors lead to satisfaction when they are present, and dissatisfaction when they are absent, this was not the case. Job satisfaction and dissatisfaction were found to stem from different sources. In particular, dissatisfaction was associated with conditions surrounding the jobs (e.g. working conditions, pay, security, quality of supervision, relations with others) rather than the work itself. Because these factors prevent negative reactions, Herzberg referred to them as hygiene (or maintenance) factors. By contrast, satisfaction was associated with factors associated with the work itself or to outcomes directly derived from it, such as the nature of their jobs, achievement in the work, promotion opportunities, and chances for personal growth and recognition. Because such factors were associated with high levels of job satisfaction, Herzberg called them motivators. Herzberg's distinction between motivators and hygiene factors is referred to as the two-factor theory of job satisfaction.

Research testing Herzberg's theory has yielded mixed results. Some studies have found that job satisfaction and dissatisfaction were based on different factors, and that these are in keeping with the distinction made by Herzberg. Other studies, however, have found that factors labeled as hygienes and motivators exerted strong effects on both satisfaction and dissatisfaction, thereby casting doubt on Herzberg's theory. In view of such equivocal evidence, we must label Herzberg's theory as an intriguing but unverified framework for understanding job satisfaction. Still, the theory is useful for describing the conditions that people find satisfying and dissatisfying on the job. The theory has also been useful in emphasising the importance of factors such as the opportunity for personal growth, recognition, and increased responsibility. Attention to such variables has stimulated much of the research and theory on job enlargement and job enrichment. In this way, Herzberg's theory has contributed much to the field of organisational behaviours, despite the lack of support for some of its key predictions.

Another difficulty here is that some of the statements contain information that is not given in the passage. In these cases you have to be very careful not to reach conclusions which are not justified by the information in the passage.

READING PASSAGE - PART II

Locke's Value Theory

A second important theory of job satisfaction is Locke's value theory. This conceptualisation claims that job satisfaction exists to the extent that the job outcomes (such as rewards) an individual receives match those outcomes that are desired. The more people receive outcomes they value, the more satisfied they will be; the less they receive outcomes they value, the less satisfied they will be. Locke's approach focuses on any outcomes that people value, regardless of what they are, and not necessarily basic lower-order needs. The key to satisfaction in Locke's theory is the discrepancy between those aspects of the job one has and those one wants; the greater the discrepancy, the less the satisfaction.




Figure 5.7 Job satisfaction: a result of the discrepancy between what we want and what we have

McFarlin and Rice conducted a study that provides good support for value theory. Using a questionnaire, these investigators measured how much of various job facets – such as freedom to work one's own way, learning opportunities, promotion opportunities, and pay level – a diverse group of workers wanted, and how much they felt they already had. They also measured how satisfied the respondents were with each of these facets and how important each facet was to them. As shown in Figure 5.7, an interesting trend emerged: those aspects of the job about which respondents experienced the greatest discrepancies were the ones with which they were most dissatisfied, and



those with which they experienced the smallest discrepancies were the ones with which they were most satisfied. Interestingly, McFarlin and Rice also found that this relationship was greater among individuals who placed a high amount of satisfaction on a particular facet of the job. In other words, the more important a particular facet of the job was believed to be, the less satisfied people were when they failed to get as much of this facet as they wanted.

An interesting implication of value theory is that it calls attention to the aspects of the job that need to be changed for job satisfaction to result. Specifically, the theory suggests that these aspects might not be the same ones for all people, but any valued aspects of the job about which people perceive serious discrepancies. By emphasising values, Locke's theory suggests that job satisfaction may be derived from many factors. In this respect, it is fully consistent with the findings of research on the causes of job satisfaction.

- 1 More and more women are now joining the paid labour force worldwide. They represent the majority of the workforce in all the sectors which are expanding as a result of globalisation and trade liberalisation the informal sector, including subcontracting; export processing or free trade zones; homeworking; and the "flexible", part-time, temporary, low-paid labour force. Even in countries which have low levels of women paid workers, such as the Arab countries, employment is rising.

- 3 Long excluded from many paid jobs and thus economically dependent on husbands or fathers, paid employment has undoubtedly brought economic and social gains to many women. For many previously inexperienced young women, the opportunity to gain financial independence, albeit limited and possibly temporary, has helped break down some of the taboos of their societies and prescriptions on women's behaviour.
- 4 Any gains, however, should be seen in a wider context. Declining economic and social conditions throughout the world, in particular declining household incomes, have compelled many women to take any kind of paid work to meet their basic needs and those of their families. The jobs available to them are, in the main, insecure and low-paid with irregular hours, high levels of intensity, little protection from health and safety hazards and few

- 5 Women's high participation in informal employment is partly due to the fact that many jobs in the formal economy are not open to them: they are actively excluded from certain kinds of work or lack access to education and training or have domestic commitments. The increase of women's participation in the informal sector has been most marked in the countries of Sub-Saharan Africa where sharp economic decline and structural adjustment policies have reduced the official job market drastically.
- 6 Job gains for some women have meant losses for others. Female employment in export production is increasing in Bangladesh, Vietnam and El Salvador, for instance, while women in South Korea, Taiwan and Hong Kong are faced with redundancies as the industries which have relied on their labour for three decades (textile, clothing, shoe and electronics) relocate elsewhere. (In South Korea, industries which tend to employ men - steel, petrochemicals, electricity, automobiles, shipbuilding, machinery - have received government subsidies to stay put.)
- 7 As domestic markets are opened up to international competition and quotas which restricted the quantity of imports from any one country are abandoned, cheap, subsidised foreign imports are threatening the livelihoods of many women small producers and entrepreneurs in "cottage industries". In countries such as India and Bangladesh, for instance, more than 90 per cent of economically-active women work in the informal sector at jobs such as hand loom weaving.

- 8 Far from escaping patriarchal control, the industrial setting invariably replicates it, the head of the factory taking the place of husband or father. To attract investors, some Asian countries such as Malaysia and Thailand emphasise the "dexterity of the small hands of the Oriental women and traditional attitude of submission". Women workers are particularly exposed to sexual harassment, a form of violence which reflects the subordination they have to submit to to be allowed to work. Complaints often lead to dismissal.
- 9 In general, women are paid less than men are, and women's jobs pay less than men's jobs. On average, most women earn 50 to 80 per cent of men's pay, but there are considerable variations. Tanzania, which ranks first in the world for pay equality, women earn 92 per cent of what men earn; in Bangladesh, they earn 42 per cent. Women also have less job security and fewer opportunities for promotion. Higher status jobs, even in industries which employ mostly women, tend to be filled by men.
- 10 In addition, women usually have to continue their unpaid domestic and caring work, such as of children, the sick and the elderly, which is often regarded as women's "natural" and exclusive responsibility. READING PASSAGE

UTILISING WOMEN'S SKILLS

Women Working

- 1 Britain has a higher proportion of economically active women than any of our EC partners, with the exception of Denmark, and the trend towards greater female participation in paid employment seems to be irreversible. The Central Statistical Office's Social Trends report, published at the beginning of this year, forecasts that the number of women in the labour force is likely to increase by 700 000 over the 1990s and that by the end of the decade no less than 45 per cent of workers will be female. It may be questioned whether industry fully utilises them.
- 2 At present a high proportion of employed women, four out of ten, work part-time compared with only ten per cent of men in employment. This development is in response to the increased opportunities available to realise two distinct goals:
 - (1) The industrial goal of achieving greater flexibility in working time and working schedules in order to improve the relationship between labour costs and business needs; and
 - (2) The personal goal of many women of participating responsibly in both economic and domestic-familial activity without subjecting themselves to intolerable strains.

Industry needs part-time workers and women often find part-time work more feasible than full-time.



- 3 While many more women would doubtless prefer to have full-time employment, most men below early retirement age would see this as a necessity. The traditional images of the "male breadwinner" and the "female housewife and mother" may be breaking down among females but this process is occurring more slowly among males. Men do adopt the role of "househusband", but their number is still small enough to make the examples newsworthy.
- 4 For this reason, a good deal of female employment, and especially that part of it which involves women with young children, occurs without much corresponding adjustment or accommodation by men or by the institutions which men have created. Men remain "free" to take on their traditional full-time breadwinner roles, but women depend on there being opportunities for them to participate in economic activity at the times and in the locations which fit in with their domestic responsibilities. However "useful" they might be to industry because they do not want the full-time engagements that are not available, their involvement remains unintegrated.

The Waste of Talent

- 5 In consequence, the talents which exist within this section of the workforce are under-utilised. They serve as "hands" hired usually to perform routine jobs which can be parcelled out in appropriate part-time lots. They may do these extremely satisfactorily and at low overall cost to the employer, but skills and competencies developed in the course of their other experiences including running a house-hold, organising efficient routines, counselling and developing children, etc. may never be given any chance to surface.
- 6 In addition they have little opportunity to contribute ideas or suggestions around or outside the immediate confines of their particular job. This is because they are not sufficiently woven into the fabric of the organisation to permit their insinuation into discussions at the right moment or with sufficient persistence to ensure that they get a hearing. They are treated as part of a peripheral workforce and their ideas have little chance of entering the mainstream of thought.
- Against this background there is little chance that they will be either rotated or promoted to any position of responsibility. Research published recently by the Institute of Manpower Studies confirms that women are generally still very underrepresented in management. It found, as many other studies of women at work have done, that although 40 per cent of the current workforce is female, women



constitute only 22 per cent of managers and only 2 per cent of senior executives. This also implies that even full-time women and those who do seek to develop a conventional career have little chance of success.

8 This may reflect stereotypical attitudes similar to those which attach to "part-timers": even full-time female employees appear to present a greater risk than full-time men of failing to make the grade as steady, reliable workers. They may declare themselves to be interested in a career, but they are much more likely than a man to succumb to the alternative career of raising children and running a family home. Therefore, so the stereotypical argument runs, they are less worthy of the employer investing training and development resources in them. If a woman is to get on, she has to surmount hurdles without much assistance and support from the employer.

Effective Utilisation

- 9 In order to utilise female talents at all effectively, it may well be necessary, as many have already argued, to provide some simple logistical supports in the form of flexible work schedules, child-care facilities and the like. But it may be even more necessary to provide greater opportunity for working women in general and part-time workers in particular, to become integrated into the mainstream of organised activity.
- 10 This can occur only if industry then treats them as worthy of it, no matter whether they are "merely" part-time or whether they choose to take some time out to start a family. Some organisations, especially those facing a tight labour market, do provide such opportunities and do attempt to keep those on leave of absence in touch with policies and practices. They are probably too few for comfort and too often stimulated by extremely short-sighted and short-lived motives. Unless these activities are integrated with the business strategy, they are unlikely to survive a slackening of the labour market or to give industry full benefit.
- 11 Finally, their potential is unlikely to be realised unless they are included in all the communication systems developed both to inform employees and to elicit their suggestions for improvement. Part-timers particularly, but also those who perform what have traditionally been regarded as women's jobs, are often excluded from these, so that their often unblinkered views are ignored.

THE CHANGING NATURE OF CAREERS

As time marches on, the nature of people's jobs changes and the characteristics of organisations change — and as a result, so too do people's careers. According to Schein, these changes can be characterised as developments along three basic dimensions summarised in his career cone (see Figure 6.10). First, careers often involve vertical movement — that is, promotions up an organisational hierarchy (such as from assistant manager to manager). Naturally, different people working in different settings experience vertical movement at tremendously different rates. Not only may people be prepared for advancement at different times, but also organisations may have different opportunities for promotion. In today's organisations, in which layers of management are being reduced all the time, there are fewer rungs in the organisational ladder, making opportunities for vertical movement more limited than they used to be.



Second, careers often involve *horizontal movement*. This reflects changes in specific job functions, or sometimes, in major fields or specialties. For example, individuals who start out in marketing may move into the related field of sales. In recent years, growing numbers of people have been willing to make such horizontal moves, even though doing so may involve a considerable amount of retraining. This trend may result from several sources, such as people's needs to seek fulfilment by doing different kinds of work, or by their belief that they might sooner be able to make a vertical movement by first moving horizontally into a field with greater opportunities for advancement.

Finally, careers also involve what Schein terms *radial movement* — shifts toward or away from the inner circle of management in an organisation, the base of power. Such movement often follows vertical movement (i.e. promotion), but not always. For example, a manager of engineering operations for a television network, who works at its headquarters, may be promoted to the vice president at one of the network's local affiliates. The promotion in this case is real, but the individual is now farther away from the organisation's inner circle of power than before (both literally in terms of miles and figuratively in terms of influence).


At the same time careers develop along these three dimensions, they also seem to move through repeated cycles of stability and change. Soon after an individual has been hired or promoted into a new position, a stage of career growth occurs. During this period, individuals consolidate their recent gains by acquiring the new skills and information needed to perform their current jobs effectively. As this process is completed, they enter a stage of stabilisation, in which they are performing their jobs to their fullest capacity and things are on an even keel (for the time being, at least). This is followed by a period of transition in which individuals prepare themselves psychologically for their next move upward. During this period, they anticipate the demands of their next stage and get ready to meet them. When the expected promotion arrives, the cycle starts over again. In short, the careers of many individuals are marked by a process in which they grow into each new position, become acclimatised to it, and then begin preparations for the next step on the ladder.

Summarising Questions

Summarising questions can be in the form of:

- a brief summary of part of the reading passage
- · a brief summary of the whole reading passage
- notes on the reading passage.

They are usually the last questions related to a reading.

The information in the summary usually has the same sequence as the information in the reading.

They require you to complete gaps in the summary with appropriate words:

- · from a box of possible answers
- from the reading passage itself.

The words you have to use are never articles (a, an, the) or prepositions (e.g. at, in, over). They are always what we call content words. They are nouns, verbs, adjectives or adverbs. For this reason a good knowledge of grammar and vocabulary can help you a lot in answeedesigned by ieltsdinhluc.vn



As these are usually the last questions for a reading passage, the best strategy for these questions is:

- to read the summary
- · if there are words given in a box, to guess an answer
- if you have to find words in the passage, to guess a probable answer
- if you can't immediately guess an answer, to think about the kind of word you need.

The practice and the exercises for summary questions are all based on passages you have already read in working through this book. This is because summary questions usually come last in a set of questions attached to a reading passage, so you will already be familiar with the content of the reading before you try to do these questions.

SPORT AND RECREATION

A large proportion of Australians, regardless of social position, income and age, participate in some form of sporting activity. Sport is a large industry in Australia encompassing not only participants but also employment within the sporting infrastructure; manufacture of apparel, equipment and other goods (e.g. trophies); tourism and support industries (e.g. printing, media). In the 25 to 34 age group 43% of men played sport, compared to 28% of women. Twenty per cent of men and 12% of women aged 65 and over played sport. DISCUSSION

- 1 This sentence summarises the information in the first paragraph. The passage tells you that sport is important in two ways: as an activity and an industry. One kind of activity is already mentioned 'recreational'. Note that this word is an adjective, therefore you need another adjective to complete the phrase. The possible answers must be either 'business', or 'social'. 'Business' is almost a synonym for 'industry', and therefore not appropriate for the answer. Therefore the answer is 'social'.
- 2, 3, 4 and 5 The sentence containing these questions is a summary of the second paragraph. The words, which must be nouns, that might be applicable are: 'players', 'non-players', 'women', 'participants' and 'spectators'. For Questions 2 and 3, you must put two types of participants. One of these could be 'women', but women are not mentioned at this point in the text. Therefore the only possibilities are 'players' and 'non-players'. It would not matter which you put first as it would still mean the same thing.

The second part of this sentence, Questions 4 and 5, is a rephrasing of the last sentence of the paragraph. It includes the information left out of the last sentence, which a reader would be able to supply for him/herself. The complete meaning of that last sentence is: 'Spectator involvement in sport was excluded [from participation]'. Therefore, the answer to Question 4 is 'spectators'. By definition, spectators cannot be players, and spectators are automatically non-players. So neither of those words is possible for Question 5. The answer is 'participants'. In this case you cannot reverse the order of the answers as it would not make sense.

- 6 & 7 The sentence containing these two questions summarises the third paragraph of the reading. The structure of the sentence indicates that for Question 6 an adverb in the comparative form is needed and for Question 7 an adjective in the comparative is required. The possible words in the box are: 'more', 'less', 'fewer' and 'most'. The percentages of men and women in sport indicate that the answer for 6 is 'less' as it is the only adverb given which reflects those figures. The rest of the paragraph indicates that the numbers of young people involved in sport is greater than the number of older people involved; therefore the answer is 'more'. 'Most' is not possible as it is the superlative form, not the comparative.
- 8 This question summarises some of the information in the last paragraph about the activities on non-players. This paragraph tells you than non-players were involved 'as administrators or committee members'. Therefore the answer to this question is 'non-players'. This means that you have used this answer twice. Sometimes you have to use the same answer twice, although it is not common in the IELTS test.



DISCUSSION

- 1 You might guess the answer for this one if you know that an orchard is where fruit is grown. However, to find the correct word in the reading, you must read all of Paragraph A and connect the fruit exports in the first sentence with the orchards in the second last sentence.
- 2 For Question 2 you also have to search Paragraph A for something that fruit can be sent in. After 'in' you need a noun, and you know that fruit goes bad quickly, so the answer is in the sentence 'Highly perishable exports prompted Cardoen Industries, ..., to produce refrigerated containers for sea and air shipments'. The question asks for only one word, so the correct answer is 'containers'. It is important that you write this answer in the plural, as the singular would require an article and also it would not be logical to have only one container.

AUSTRALIAN POPULAR MAGAZINES

A The magazine as a product for leisure reading, enjoyment and information, or, as the Gentlemen of the day would have put it 'edification', had its origins in England during the early years of the eighteenth century where the innovator was Daniel Defoe, the writer of Robinson Crusoe. The word magazine comes from the French magasin which originally meant a storehouse, an apt term since the first printed magazines were holdings for a miscellany of writings on various subjects. Defoe titled his magazine The Review, which, five years after the first issue, was followed by two other now famous magazines The Tatler and The Spectator both publications founded by the same partner-writers Richard Steele and Joseph Addison.

B As for Australian popular magazines, initially, during the founding days of the colonies, readers at the time depended on the slow sailing ships from 'home' to bring them, among the other necessary items, newspapers and journals.

C It was not until 1855 that Australia produced its own, and first popular magazine. This was the highly successful *Melbourne Punch*, which had a life span reaching into the first quarter of the twentieth century.

D Popular illustrated magazines rapidly became an important and

significant factor to the literate in Australia, who were forming our national image, as were the singers of ballads and strolling entertainers who were also making a major contribution. Out of this background the now famous old Bulletin emerged in 1880. From the start The Bulletin policy was to foster and encourage Australian writers and artists: it succeeded in making the names and reputations of Henry Lawson, 'Banjo' Paterson, Steele Rudd and scores of others. It created a new, unique school of black-and-white art which, for instance, gave Phil May his big chance and eventual world recognition. The influence of The Bulletin was such that this era of the legendary 'nineties' is regarded as the source of our national culture.

From this Australian pre-Federation era a number of fascinating magazines were not only founded, but many were originated and owned by distinguished writers of the day. These included the writers Henry Kendall, Marcus Clarke, Rolf Boldrewood, Randolph Bedford, Edward Dyson, Norman Lindsay and C. J. Dennis among others.

E As they were developed technical advances were promptly exploited, the most sensational being the development of photo-process engraving which allowed, for the first time, the reproduction of 'half-tone' photographs. This ingenious method simply required a

photograph to be re-photographed through a dotted glass screen on to a metal sheet where, after an acid bath, the tones are simulated by a pattern of minute, raised dots varying in size. When inked the metal sheet is ready for reproducing a facsimile photograph made of tiny dots. Previously, a scene or an event was drawn in reverse, or back to front, by an artist on to a prepared block of wood. This was then given to an engraver who, with a variety of delicate cutting tools, would gouge away areas of the drawing leaving a raised surface which, when inked and pressure applied would give a black and white impression of the image. And for the first time too photo-engraving enabled an artist to draw a cartoon, for instance, in any manner or style he chose and the printed result, which could now be enlarged or reduced in size, would be accurate in every detail just as it was drawn.

Other not so significant technical developments have been high-speed printing presses, simultaneous multi-colour printing, and certain electronic 'scanner' equipment for preparing colour illustrations.

F By and large contemporary Australian magazines today do not differ greatly in content from those of the last century. There are some new directions: the high political content of The Bulletin for instance, reflects an awareness that Australia is increasingly being drawn into the wider international community – the features and articles about 'Big Business', home and overseas reflect this appreciation.

Whilst some one-time popular and very successful magazines - Pix and the original People for example - have not survived the years following World War II into the 1980s, the long running Australasian Post has managed not only to survive for 120 years (with a slight name change in 1946) but the magazine has been, for quite some time now, heading the list of the largest circulation for an Australian magazine of its kind. A large part of this success has resulted from a conscious editorial policy of an emphasis on Australiana. Other contemporary magazines like the Australian Penthouse and Playboy, Cleo and Cosmopolitan - there are others - have no policy to pursue national identity, but rather to embrace an international quality or, in the case of Penthouse, some other point of interest.

G Today, at a time of renewed national assessment, publications of the past that may have seemed inconsequential assume fresh importance as a source for the broad study of our culture. The changes in social behaviour, tastes, attitudes, fashion and manners which they reflect have become a large part of our conception of ourselves.

RADIATION AND HUMAN HEALTH

A Radioactivity occurs naturally. The main source comes from natural sources in space, rocks, soil, water and even the human body itself. This is called background radiation and levels vary from place to place, though the average dose is fairly constant. The radiation which is of most concern is artificial radiation which results from human activities. Sources of this include the medical use of radioactive materials, fallout and contamination from nuclear bomb tests, discharges from the nuclear industry, and the storage and dumping of radioactive waste.

B While artificial radiation accounts for a small proportion of the total, its effects can be disproportionate. Some of the radioactive materials discharged by human activity are not found in nature, such as plutonium, while others which are found naturally may be discharged in different physical and chemical forms, allowing them to spread more readily into the environment, or perhaps accumulate in the food-chain.

For all these reasons, simple comparisons of background and artificial radioactivity may not reflect the relative hazards. Equally important, it has never been shown that there is such a thing as a safe dose of radiation and so the fact that we are progressively raising global levels should be of as much concern to us as the possibility of another major nuclear disaster like Chernobyl. Every nuclear test, nuclear reactor or shipment of plutonium means an additional and unnecessary health risk.

C In general, the effects of radiation can be divided into those which affect the individuals exposed and those which affect their descendants. Somatic effects are those which appear in the irradiated or exposed individual. These include cancer and leukaemia. Hereditary or genetic effects are those which arise in subsequent generations.

Many of the elements which our bodies need are produced by the nuclear industry as radioactive isotopes or variants. Some of these are released into the environment, for example iodine and carbon, two common elements used by our bodies. Our bodies do not know the difference between an element which is radioactive and one which is not. So radioactive elements can be absorbed into living tissues, bones or the blood, where they continue to give off radiation. Radioactive strontium behaves like calcium - an essential ingredient in our bones - in our bodies. Strontium deposits in the bones send radioactivity into the bone marrow, where the blood cells are formed, causing leukemia.

D There are three principal effects which radiation can have on cells: firstly the cell may be killed; secondly the way the cell multiplies may be affected, resulting in cancer; and thirdly damage may occur in the cells of the ovaries or testes, leading to the development of a child with an inherited abnormality.

In most cases, cell death only becomes significant when large numbers of cells



are killed, and the effects of cell death therefore only become apparent at comparatively high dose levels. If a damaged cell is able to survive a radiation dose, the situation is different. In many cases the effect of the cell damage may never become apparent. A few malfunctioning cells will not significantly affect an organ where the large majority are still behaving normally.

However, if the affected cell is a germ cell within the ovaries or testes, the situation is different. Ionising radiation can damage DNA, the molecule which acts as the cell's 'instruction book'. If that germ cell later forms a child, all of the child's cells will carry the same defect. The localised chemical alteration of DNA in a single cell may be expressed as an inherited abnormality in one or many future generations.

In the same way that a somatic cell in body tissue is changed in such a way that it or its descendants escape the control processes which normally control cell replication, the group of cells formed may continue to have a selective advantage in growth over surrounding tissue. It may ultimately increase sufficiently in size to form a detectable cancer and in some cases cause death by spreading locally or to other parts of the body.

E While there is now broad agreement about the effects of high-level radiation, there is controversy over the long-term effect of low-level doses. This is complicated by the length of time it takes for effects to show up, the fact that the populations being studied (bomb survivors, people exposed to nuclear tests or workers in the nuclear industry) are small and exact doses are hard to calculate.

All that can be said is that predictions made about the effects of a given dose vary. A growing number of scientists point to evidence that there is a disproportionately high risk from low doses of radiation. Others assume a directly proportionate link between the received dose and the risk of cancer for all levels of dose, while there are some who claim that at low doses there is a disproportionately low level of risk.

ASIA'S ENERGY TEMPTATION

Nuclear power supplies 5% of the world's energy from more than 400 plants. But with the exception of France and Japan, the rich world has stopped ordering new reactors. A technology that was once deemed both clean and "too cheap to metre" has proved to be neither. The industry's chief hope now rests on the poor world. Many western governments which sang nuclear's praises now admit that gas and hydropower can produce cheaper electricity.

The economics of nuclear power in the poor world could prove to be worse still. As in the rich world, fossil fuels such as gas and coal are invariably cheaper. In China the case for nuclear power may be a little stronger as domestic reserves of coal – though huge – are located far from some areas of growing electricity demand. But most developing countries, including China, are strapped for cash and need to increase electricity supply quickly to meet soaring demand. Nuclear plants fail on both counts: they are hugely capital-intensive, and can take as long as ten years to build.

Those still charmed by nuclear power nowadays make three new arguments in its favour: that it is a defence against climate change, against another OPEC-administered oil shock, and against the inevitable exhaustion of fossil fuels. None bears close examination.

At present rates of demand, the world has enough oil to last for more than 40 years, enough gas for more than 60 years and enough coal for more than 230 years. Naturally, demand will increase; but so will reserves as companies explore more widely and costs fall. Since 1970 viable reserves of oil have almost doubled while those of gas have leapt three-fold. One distant day a crunch will come, but as it approaches fossil-fuel prices will rise, making alternative forms of energy, perhaps including nuclear power, competitive. That is no reason to spend on nuclear now.

An oil shock is a more worrying prospect, despite today's low oil price and OPEC's present inability to budge it upwards. After all, the cartel still sits on 75% of the world's economically viable reserves, and the politics of the Middle East can change at a stroke. However, even if an oil shock is a real danger, building nuclear



reactors is not a good way to avert it. A higher oil price would have a relatively small effect on the supply of electricity – the only sort of energy that nuclear power can now provide. Just over a tenth of the world's electricity (and 14% of Asia's) is generated from oil, and the proportion has fallen steadily since 1970.

Besides, there are superior, non-nuclear, ways to prepare for an oil shock. Governments could take advantage of today's low oil prices to build up their stocks. Especially where congestion and pollution are serious problems, they could try to restrict the growth of car use, or promote cars which guzzle less fuel. For governments keen to reduce electricity's remaining dependence on oil still further, there are usually cheaper alternatives to nuclear, such as coal or hydropower.

Climate change is a legitimate worry. Although still riddled with uncertainties, the science of climate change is becoming firmer: put too much carbon in the atmosphere and you might end up cooking the earth, with possibly catastrophic results. But here again, switching immediately to nuclear power is not the best response. Cutting the hefty subsidies that go to the world's coal producers would help tilt the world's energy balance towards natural gas, which gives off much less carbon dioxide. Developing countries subsidise electricity prices to the tune of up to \$120 billion a year, according to World Bank estimates. If prices reflected the true costs of generation, electricity demand would fall, thus cutting greenhouse emissions.

Once the tough job of cutting subsidies is over, governments might want to reduce greenhouse gases further. Again there are carbon-free energies that merit more subsidies than nuclear. The costs of many renewable technologies, such as solar and wind power, have fallen dramatically in recent decades.

Moreover, supporting nuclear power to ward off climate change means swapping one environmental risk for another. Voters in many countries fear radiation like the plague. The risks of nuclear accidents may be tiny, but when they happen they can be catastrophic. Renewables are not without their environmental disadvantages (wind turbines, for example, can be unsightly on hilltops), but are much cleaner than nuclear. The billions rich countries each year pump into nuclear research would be better spent on renewables instead.

Having been invented, nuclear power will not disappear. The nuclear industry still has a job to do, running existing nuclear plants to the end of their lives as cheaply and safely as possible. For now, the case for nuclear power is full of holes. Asia should resist the temptation to throw its money into them.

NEW-AGE TRANSPORT

Computerised design, advanced materials and new technologies are being used to produce machines of a type never seen before.

It looks as if it came straight from the set of *Star Wars*. It has four-wheel drive and rises above rocky surfaces. It lowers and raises its nose when going up and down hills. And when it comes to a river, it turns amphibious: two hydrojets power it along by blasting water under its body. There is room for two passengers and a driver, who sit inside a glass bubble operating electronic, aircraft-type controls. A vehicle so daring on land and water needs windscreen wipers – but it doesn't have any. Water molecules are disintegrated on the screen's surface by ultrasonic sensors.

This unusual vehicle is the Racoon. It is an invention not of Hollywood but of Renault, a rather conservative French state-owned carmaker, better known for its family hatchbacks. Renault built the Racoon to explore new freedoms for designers and engineers created by advances in materials and manufacturing processes. Renault is thinking about startlingly different cars; other producers have radical new ideas for trains, boats and aeroplanes.

The first of the new freedoms is in design. Powerful computer-aided design (CAD) systems can replace with a click of a computer mouse hours of laborious work done on thousands of drawing boards. So new products, no matter how complicated, can be developed much faster. For the first time, Boeing will not have to build a giant replica of its new airliner, the 777, to make sure all the bits fit together. Its CAD system will take care of that.

But Renault is taking CAD further. It claims the Racoon is the world's first vehicle to be designed within the digitised world of virtual reality. Complex programs were used to simulate the vehicle and the terrain that it was expected to cross. This allowed a team led by Patrick Le Quement, Renault's industrial-design director, to "drive" it long before a prototype existed.

Renault is not alone in thinking that virtual reality will transform automotive design. In Detroit, Ford is also investigating its potential. Jack Telnac, the firm's head of design, would like designers in different parts of the world to work more closely together, linked by computers. They would do more than style cars. Virtual reality will allow engineers to peer inside the working parts of a vehicle. Designers will watch bearings move, oil flow, gears mesh and hydraulics pump. As these techniques catch on, even stranger vehicles are likely to come along.



Transforming these creations from virtual reality to actual reality will also become easier, especially with advances in materials. Firms that once bashed everything out of steel now find that new alloys or composite materials (which can be made from mixtures of plastic, resin, ceramics and metals, reinforced with fibres such as glass or carbon) are changing the rules of manufacturing. At the same time, old materials keep getting better, as their producers try to secure their place in the factory of the future. This competition is increasing the pace of development of all materials.

One company in this field is Scaled Composites. It was started in 1982 by Burt Rutan, an aviator who has devised many unusual aircraft. His company develops and tests prototypes that have ranged from business aircraft to air racers. It has also worked on composite sails for the America's Cup yacht race and on General Motors' Ultralite, a 100-miles-per-gallon experimental family car built from carbon fibre.

Again, the Racoon reflects this race between the old and the new. It uses conventional steel and what Renault describes as a new "high-limit elastic steel" in its chassis. This steel is 30% lighter than the usual kind. The Racoon also has parts made from composites. Renault plans to replace the petrol engine with a small gas turbine, which could be made from heat-resisting ceramics, and use it to run a generator that would provide power for electric motors at each wheel.

With composites it is possible to build many different parts into a single component. Fiat, Italy's biggest car maker, has worked out that it could reduce the number of components needed in one of its car bodies from 150 to 16 by using a composite shell rather than one made of steel. Aircraft and cars may increasingly be assembled as if they were plastic kits.

Advances in engine technology also make cars lighter. The Ultralite, which Scaled Composites helped to design for General Motors, uses a two-stroke engine in a "power pod" at the rear of the vehicle. The engine has been developed from an East German design and weighs 40% less than a conventional engine but produces as much power. It is expected to run cleanly enough to qualify as an ultra-low emissions vehicle under California's tough new rules.

GETTING GIRLS ON-LINE

When Nancy Leveson, now a computer science professor at the University of Washington, was teaching math at a California high school, her best student also happened to be one of the prettiest and most popular girls around. And when the girl got the highest score on a test, Leveson thought nothing of announcing the achievement while handing back the papers. As soon as the class ended, though, the distraught student approached. She begged her teacher never, ever to embarrass her like that again.

The incident happened nearly 20 years ago, but Leveson notes that little has changed. Now, as then, too many teenage girls feel uncomfortable and even unwelcome in the realms of math, science and computing. Research shows that girls who are gifted in these subjects in elementary school begin to shy away from them by the seventh grade. Eventually, they convince themselves that these are male domains. "By saying only men are good at these things, you make the women who are good at them seem like freaks," says Leveson.

Increasingly, however, educators are trying to reverse the process by retraining teachers and redirecting students. Funded with more than \$1 million by the National Science Foundation (NSF) and seven corporations, Computer Equity Expert Project (CEEP) showed 200 math and computer-science teachers how to recognise and eliminate gender bias in their classrooms. CEEP urged teachers to bring more girls into the world of computers by setting up mentoring programs with older students and having girls-only days at the school computer labs.

Both public and private schools are trying to close the technology gap. Because girls tend to do better in the sciences without the distraction of boys, three California schools have started girls-only math classes over the last two years, with promising results. Other schools are hooking up with colleges for help and inspiration.

But however wonderful the subject looks in high school, interest often diminishes in college, where women earned only 30% of the undergraduate degrees awarded in computer science in 1991, and 16% in engineering in 1993, as opposed to medical school, where women make up 36% of total enrolment. The proportion shrinks still more at the doctoral level, where women receive only 15% of computer science PhDs and under 10% of engineering PhDs.



Many college women are turned off by the macho swagger of technojocks at schools like MIT, where staying awake for three days to perfect a piece of software is seen as a test of virility. That kind of attitude "sets cultural parameters not just for MIT but for the intense nature of the computer culture everywhere," says Steven Levy, author of *Hackers: Heroes of the Computer Revolution*. As a result, it's hard to find female role models in computer science.

To keep women interested in the field, Nancy Leveson and a colleague from the University of British Columbia spearheaded a program that will match 20 female undergraduates with faculty mentors around the country this summer, thanks to a \$240 000 grant from the NSF.

In Rochester, NY, the Rochester Institute of Technology's Women in Science, Engineering and Math mentoring program aims to spark high school girls' career interests by linking 140 girls and professional women in a computer network. Coordinators, who hope to extend the four-month program to three years, note the intense interest shown by girls and women. "I can't keep the mentors away," says Carol O'Leary, who helped set the program up. "I was looking for 40, and I have 67. Women are anxious to give of themselves."

Eventually, these computer educators would like to make gender-specific programs obsolete, but that will happen only when computer-science education becomes more creative, according to Paula Rayman, director of Pathways for Women in the Sciences, a research program at Wellesley College. By way of example, Rayman points to her 9-year-old daughter, Lily, whose fourth-grade class at the Bowman Elementary School in Lexington, Mass., is learning several sciences under the guise of bicycle repair. The kids aren't just fixing bikes but ingesting knowledge about mechanics, scientific history and the physics of motion. They're also using their computers to generate charts, graphs and databases. Children of both sexes are eager to work with computers because the machines are revealed as both entertaining and useful, not just as a source of boring drills or violent games, which girls usually find unappealing.

"When it comes to girls and computers," says Rayman, "we've found that there are three ingredients for user-friendliness: hands-on experience, teamwork and relevance." These ingredients, of course, would increase anyone's mastery of computers, as well as the usefulness of the machines. By trying to do a better job of teaching girls, computer scientists may learn quite a lot themselves.

DO WE NEED CITIES ANY MORE?

A I don't want to live in a city. Perhaps we divide naturally into two types: those for whom cities are vibrant and exciting, a focus for human activity; and those for whom they are dirty, noisy and dangerous. It may be unfashionable, but I'm in the latter camp. I do not believe that we are a species whose behaviour improves in overcrowded conditions.

B A new study proposes a significant increase in the capacity of towns and cities through a combination of increased housing densities, lower onplot provision for cars and more onstreet parking, and the re-use of marginal open space that is 'devoid of any amenity value'. The benefit of this approach is to reduce the loss of green fields and to help 'move towards more sustainable patterns of development'.

C This study suggests that it would be possible to achieve a 25% increase in density in a typical provincial city without changing the traditional street scene, although it would be necessary to reduce the size of the houses and substitute parking spaces for garages. Therefore, the cost of this approach is to have more people living in smaller homes at higher densities, along streets that are lined with parked cars. Can we really accept the notion that space within dwellings may be reduced even further? In times when, we are told, living standards are rising in real terms, is it realistic to seek to reduce personal space standards?

D The streets of many inner suburbs are already lined with cars on both sides, reducing movement to a single lane. Increasing densities means accepting urban streets that are designed as linear car parks, bounded by even smaller living units and tempered only by occasional trees sprouting from the tarmac. Would the benefits of higher density be worth the disadvantages of increasing on-street parking? Can we achieve a satisfactory visual environment from such raw materials? Higher urban densities may be communally good for us, but they will fail to meet the aspirations of many prospective home owners.

E Those without economic choice can be directed to live in this way, but if we are to continue to rely on the private sector to produce this urban housing, it will need to appeal to the private developers' customers. Who will choose to live in these high-density developments of small dwellings, with minimal open space and a chance to park on the highway if you are lucky enough to find a space? The main consumers will be single people, couples without children, and perhaps some 'empty nesters' (people whose children have grown up and left home). These are people who can choose to spend much of their time outside their home, making the most of those urban cultural opportunities or getting away at weekends to a country cottage or sporting activities.



F The combination of a young family and a mortgage restricts the mobility and spending power of many couples. Most people with a family will try to avoid bringing up their children in a cramped flat or house. Space for independent activity is important in developing the individual and in maintaining family equilibrium. The garden is the secure place where the children can work off excess energy.

G There is a danger that planners may take a dispassionate, logical view of how we should live, and seek to force society into that mould. A few years ago a European Commission study provided a good example of this. It took the view, quite sensibly, that housing should not be under-occupied because this is a waste of resources. Therefore, it would be much better if the many thousands of old ladies who live alone in large detached houses would move into small urban flats, thus releasing the large houses for families. What the study

failed to recognise was that many of those old ladies prefer to continue to live in their family home with their familiar surroundings and, most importantly, with their memories. What is good for us is not necessarily what we want.

H The urban housing option may be technically sustainable, but individually unacceptable. There still seems to be a perception among planners that new housing investment can be forced into those areas that planners want to see developed, without proper consideration of where the prospective purchasers want to live. There is a fatal flaw in this premise. Housing developers run businesses. They are not irrevocably committed to building houses and they are not obliged to invest their resources in housing development. Unless there is a reasonable prospect of a profit on the capital at risk in a housing project, they may simply choose to invest in some other activity.




Figure 1 World grain harvested area, 1950-96








Figure 3 Sales of computers, 1995








Figure 5 Number of tourists visiting a particular country






Figure 8 Number of new model cars produced





Here is a sample answer to this Practice for Task 1.

The two pie charts show the proportion of males and females in employment in 6 broad categories, divided into manual and non-manual occupations. In general, a greater percentage of women work in non-manual occupations than work in manual occupations, and the reverse is true for men.

In the non-manual occupations, while a greater percentage of working women than men are found in clerical-type positions, there is a smaller percentage of women than men employed in managerial and professional positions. The percentage of women employed in other non-manual occupations is slightly larger than the percentage of men in these occupations.

In manual employment, the biggest difference between the two sexes is in the employment of craft workers, where males make up 21% of the workforce and females just 4.5%. Furthermore, the



percentage of women working as general labourers is very small, only 0.5%. There is not a great deal of difference between the percentage of men doing other forms of manual work (28%) and women in other manual work (32%).

In conclusion, the two charts clearly show that women do not have the same access as men to certain types of employment.




Figure 11 Persons arrested in past five years – reasons for most recent arrest, 1994




Figure 12 Car colours





The table uses four broad economic indicators to show the standard of living in five selected countries in 1982.

As can be seen, the USA — an industrialised country — had the highest GNP and daily calorie intake, the longest life expectancy and the lowest infant mortality rate. The other developing countries had a considerably lower quality of life.

Egypt, Indonesia and Bolivia were similar in their range of indicators, with Egypt having the highest quality of life amongst the three. However, Egypt's infant mortality rate was slightly higher than Indonesia's, at 97 deaths per 1000 compared to 87 in Indonesia.

Bangladesh had by far the lowest quality of life in all the four indicators. Its GNP was one hundred times smaller than the USA's. Its calorie intake and life expectancy were about half those in the USA and its infant mortality rate was 10 times greater.

In conclusion, it can be seen from the economic indicators that the four developing countries have to develop a lot more before reaching the same level of quality of life as the USA.

Here you have to have some knowledge of the fact that there is one developed country and three developing countries represented in the table. This conclusion summarises the information by stating the obvious disparity between the developed and developing countries.



A structure which houses turbines is built across a bay or somewhere where a large body of water can be contained. The structure can also have a roadway built on top of it, thus providing dual services. When the water level on one side of the structure is significantly higher than the other side, i.e. at high tide or at low tide,



the sluice gates are opened to allow the water to flow. The water passes through tunnels where the generators are housed and causes them to spin. This creates electricity, which is then harnessed for use.





This how a student might have answered this task.

The graphs present information on the number of TU sets imported and bought and the overall production of consumer goods in Russia in the last decade.

The production of consumer goods in 1985 stood at 100 million. Then there was a slight decrease and then a steady rise to reach approximately 125 million goods in 1990. After this peak the production fell sharply to 70 million goods in 1994.

The production of TV sets in 1991 was approximately 90 million. Then television production fell steadily, except for a slight rise in 1993, to around 20 million TV sets in 1995. The percentage of TV sets increased from C^0_c to just over 4^0_c in 1995. This was a steady rise.

In conclusion, the drop in consumer goods was due to the economic difficulties in Russia.

COMMENT

This essay is reasonably successful because:

- the details are nearly complete (the comments made on each graph line are brief and reasonably accurate)
- it is well organised
- · the sentences are also easy to understand
- the sentences are varied and accurate.

However, it didn't quite answer the task. Although the details are complete, there is no general statement to mention how the graphs related to each other, i.e. 'Consumer production decreased which affected TV production. In contrast, there was an increase in the number of imported TV sets.'

Also, the conclusion is inaccurate. The language used is too definite. There may have been other causes of the changes in the graph, i.e. 'The drop in consumer production was possibly due to...'




Figure 21 Working patterns of mothers with young children, Great Britain



Here is how a student might have answered this task.

In Great Britain, there are many women who want or need to continue working even after they have children. The four charts show the working patterns of mothers with young children to care for.

At first, mothers with their youngest dependent child aged 0–2 years, there is 11% women working full-time and 19% women working part time. The women who are not working is 70%.

The mothers with youngest dependent child aged between 3 to 4 years, almost half of them not work. There is 46% women working part time and the women who are working full time is 11%. It increase.

Then, the mothers with youngest dependent child aged between 5—9 years 38% of them are not working. There is 48% women working part time and the women who are working full time is 14%. The number of women working full time was increase in this chart and the number of working part time increase 13% from chart 2 and increase 29% from chart 1.

Finally, the chart 4 showed that the mother with dependent child aged 10 years has the biggest percentage number. There is 45% women working full time and 25% part time.

COMMENT

This essay has a few problems because:

- the sentences are not varied and there are some grammatical errors (Each paragraph is basically expressed the same way.)
- it is not very well organised (The overall structure of the essay is good. However, the details within each paragraph are not consistent: e.g. 'from largest percentage to smallest percentage' or 'from women not working to women working full time'.)
- some of it is not very easy to understand (The writer tried to mention the changes from chart to chart. It would have been easier to do this as a general statement.)

However, the writer has tried to answer the question and most details were reported.

Here is how a student might have answered the task.

Housing satisfies the essential human needs for shelter, security and privacy. Internationally, shelter is recognised as a basic human right. The adequacy or otherwise of housing is therefore an important component of individual wellbeing. Housing also has an enormous significance in the national economy, with its influence on investment levels, interest rates, building activity and employment.

The table shows that the separate house was the most popular type of dwelling in Australia in 1994, which made up 79% of all dwellings. Tasmania had the highest proportion of separate houses (85%) and the northern territory the lowest (63%). All other States and the Australian Capital Territory were in the range of 76 to 82%.

Flats or apartments were in the next most common type of dwellings. Twelve per cent of dwellings in Australia were of this design. South Australia (6%) and Western Australia (7%) had relatively low percentages of flats or apartments. The Northern Territory with 25% had the highest proportion of flats or apartments.

COMMENT

This essay has some problems because:

- some of it did not answer the question (The introduction is too long and irrelevant.)
- some important details are missing (One column of the table was not mentioned.)

However, it is well organised and easy to understand, and the sentences are accurate and varied.



Task 2

Writing Task 2 is different from Task 1 because:

- you are writing for an educated non-specialist audience and not a university lecturer. Therefore your language need not be as formal
- you are expected to give your opinion
- you have to write 250 words in 40 minutes instead of 150 in 20 minutes.

Before writing your answer you should spend five minutes planning. These are steps that you should go through.

- Read the questions and the instructions carefully.
- Analyse the topic and the focus.
- Decide what you think about the question.
- Brainstorm ideas to be used in your answer.
- Fit these ideas into an essay plan divided into paragraphs.
- Begin writing your introduction.

Topic/Focus

Present a written argument or case to an educated non-specialist audience on the following statement.

The internet will bring about a new freedom of information and so narrow the technology gap between developed and developing countries.

In the question above the topic is the internet. We know this because the internet is the subject of the sentence. However this does not mean that the examiner wants you to write down everything you know about the internet.

The rest of the sentence focuses the topic to the internet's effect on the freedom of information and on the possibility of it narrowing the technology gap. The question asks you to 'write an argument or case' which means that you must argue for or against the statement.

Therefore the question is:

Will the internet bring about a new freedom of information and will this freedom of information narrow the technology gap?

Another way of analysing a question is to underline key words, as in the question below.

Due to the <u>increase in unemployment</u> in many countries, <u>companies</u> are beginning <u>to retire</u> their <u>employees early</u>. This leads to a <u>loss of valuable expertise</u>. At what age do you think people should retire?

The topic of this essay is the actual question: At what age should people retire? The focus is: Companies lose valuable expertise by retiring employees early.

Some people may say that education gives people unrealistic ambitions; the law of the market place decrees that not every one can be a managing director. In fact for every boss there must be many more employees, so some countries believe there is very little point in training people for a level of job that they can never hope to achieve. Organising the Paragraph

In essays, paragraphs usually have a standard format.

- The first sentence is a topic sentence which explains the main point.
- The next few sentences develop the theme of the topic sentence.
- The last sentence should lead into the next paragraph.

Therefore, a standard paragraph should look like this.

Topic sentence

It is often said that people need to work to feel useful. This is not true.

Supporting arguments

It is doubtful whether most of the jobs people do are of any value to society. It is hard to imagine people getting much satisfaction from the usual paper shuffling that takes place in most offices. Therefore if a lot of jobs are of little value to the world and some jobs are actually harmful to mankind, there is no reason for people to feel guilty about staying at home and doing something more interesting instead. In fact it could be said that in these times of high unemployment it is more useful not to work as you are giving other people opportunities to feel fulfilled.



Summary

As most jobs are neither interesting nor productive, the idea of working to contribute to society is not realistic.

Cohesion

- · cause and effect
- · contrast.

CAUSE AND EFFECT

The first sentence is the reason for the second sentence. If we use 'so' we join the two sentences together. If we use 'therefore' we start a new sentence.

It is also possible to change the two sentences round so the first sentence is the result and the second sentence is the reason.

I'm tired this morning because I went to a party last night.

Grammar — Tense Check

The Present Simple Tense

The present simple tense is used to describe:

- habits
- things that are always true.

This tense is often used for IELTS Task 2 essays to describe existing situations.

Examples

Many trees take twenty or thirty years to reach their full size.

Many people still don't have enough to eat.

Many governments consider money to be more valuable than people.

The space program is very expensive.

The Present Perfect Tense

The present perfect tense is used in three situations.

1 Events starting in the past and continuing into the present.

Examples

The world population has grown rapidly over the last 100 years.

There have always been wars.

Nuclear weapons have not been used in the last 50 years.

2 Something that happened in the past but has a general present result.

Examples

Mary has had her baby.

Recently prices have risen.

The World Bank has just issued a report.

In all these examples the event happened in the recent past and is still news now.

3 Experience. The present perfect is used to talk about an event that happened in the past, where the time or the frequency are unknown.

Examples

I have seen a ghost. (When?)

Man has been to the moon. (When? How many times?)

In this use of the present perfect, it is not possible to use the continuous form.



For the purposes of Task 2 essays, you are most likely to use 'will' to write about the future.

Examples

The rainforests will vanish in the next 20 years.

Most diseases will be curable in 50 years time.

Remember: 'will' is always followed by a verb in the infinitive without 'to'.

As most donor countries were already repaid both in terms of money and in terms of economic interest, it is morally right for developing countries to refuse to pay back foreign loans.

Future Possibilities

Often in Task 2 essays, it is necessary to speculate on the possible results of a future action. This is often done by using a conditional clause.

Example

If the rainforests are cut down, they will become deserts.

The first part of the sentence ('If the rain forests are cut down') presents a possible future situation. The second part of the sentence ('they will become deserts') describes the possible future consequences of the first statement.

Notice the first part of the sentence uses the past tense while the second section uses 'would' instead of 'will'. Like all modal verbs, 'would' is followed by a verb in the infinitive without 'to'.

Notice that 'I' is followed by 'were'. This is only possible in conditional sentences.

Modals

Modal verbs include: must, have to, should, don't have to, mustn't, should, shouldn't, could, couldn't, can, can't, would, wouldn't, will and won't.

In a sentence they always come after the subject and before a verb in the infinitive without 'to'.

I might go on holiday after the IELTS Test. New laws must be made to control pollution.

The two pie charts show the proportion of males and females arrested and the bar chart shows reasons why they were arrested.

In general females were arrested much less frequently than males and were arrested mostly for public drinking and assault, whereas males were more likely to be arrested for a range of other crimes.

The pie chart shows that about one third of the male population was arrested in 1994, while only nine per cent of the female population was arrested. The highest percentage of arrests of men, which was approximately 32%, was for public drinking. However, this percentage was less than the percentage of females arrested for the same reason, which was approximately 37%. Males were more commonly arrested for drink driving, which constituted just over 25%, breach of order (about 17%), other crimes (approximately 17%) and theft (16%). Other offences in which females were more commonly arrested than males were for assault, where it constituted just under 18% of the arrests. Five per cent of men and about 6.5% of women refused to say why they were arrested.

It appears that women are either more lawabiding than men or that law enforcement officers are more reluctant to arrest women.

EXERCISE 15: SAMPLE ANSWER

The table shows the differences in salaries for males and females for several jobs at the National Institute of Health (NIH).

As can be seen, men's salaries exceed those of women in all positions except for one job type. There are also many more males employed at the NIH than females.

It is clear that females at the NIH earn significantly less money than males with differences in salaries ranging between \$197 and \$9121. For example, a male investigator with a PhD earns \$67 131 whereas a female in the same position earns \$61 164. It is only in the position of Lab Chief MD where salaries for females are higher (by \$10 509). However, it must be noted that there are only seven women in this position.

There are 483 males with MD qualifications compared to just 71 females. Similarly there are 473 male employees who have a PhD whereas there are only 118 women. The biggest difference in numbers for any one position is in the position of investigator with a PhD. There are 251 males and only 85 females.

In summary, it is clear that there is little equity between the sexes at the NIH in terms of salary and numbers of each sex employed.
